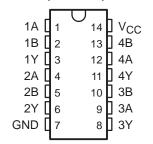

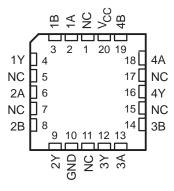

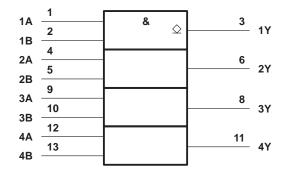


SN54ALS09 . . . FK PACKAGE (TOP VIEW)

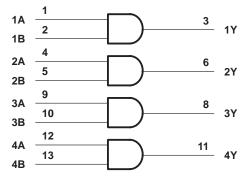

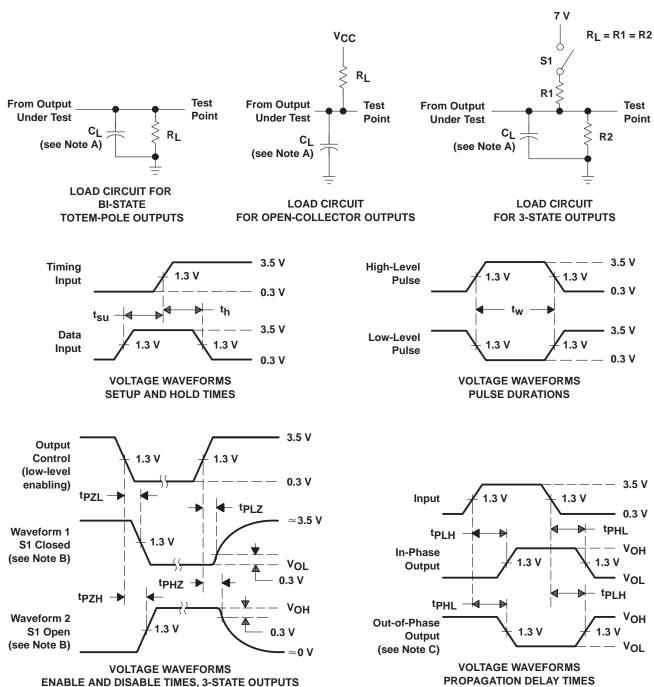

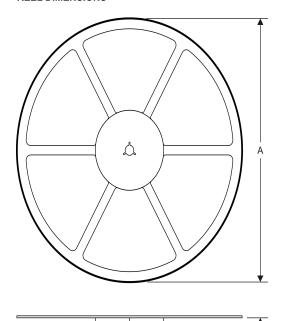
